WHAT IS DPC?

Direct Primary Care (DPC) is an innovative alternative payment model improving access to high functioning healthcare with a simple, flat, affordable membership fee. No fee-for-service payments. No third party billing. The defining element of DPC is an enduring and trusting relationship between a patient and his or her primary care provider.



WHAT IS DPC?

Direct primary care agreement" means a contract between a primary care provider and an individual patient or his or her legal representative in which the health care provider agrees to provide primary care services to the individual patient for an agreed-upon fee and period of time.

A "direct primary care" practice:

- 1. Charges a periodic fee for services
- 2. Does not bill any third parties on a fee for service basis
- 3. Any per visit charge must be less than the monthly equivalent of the periodic fee



DPC VS CONCIERGE

Concierge


- Fees range from \$101 \$225 per month
- Skew upper middle class, with household earnings of \$125,000 -\$250,000 per year
- Largely primary care services
- Bill insurance

DPC

- Fees range from \$25 \$85 per month
- Typically Generation X and Millenial with household earnings below \$100,000 per year
- Primary, preventative, urgent care, chronic disease management and wellness support
- No insurance required or used
